The IZARD County Consolidated School Board met in regular session on April 27, 2022, in the IZARD County High School Cafeteria.

Roll call showed Robert Reeves absent.

Julia Chapman made a motion, seconded by Dr. Candace Killian, to approve the minutes of the March 16, 2022, regular meeting. Motion passed, 6-0.

Mike McCandlis made a motion, seconded by Dr. Candace Killian, to approve the financial report. Motion passed, 6-0.

Superintendent Fred Walker told the board that the Cougar Stadium and Track and Field Complex construction project had been slowed some by the weather but it is still scheduled to be completed in July 2022.
