The IZARD County Consolidated School Board met in regular session on August 8, 2016, in the IZARD County High School Board Room.

Roll call showed Danny Blankenship absent.

Mike McCandlis made a motion, seconded by Robert Reeves, to approve the minutes of the July 11, 2016 regular meeting. Motion passed, 6-0.

Julia Chapman made a motion, seconded by Robert Reeves, to approve the financial report. Motion passed, 6-0.

Debbie Moody made a motion, seconded by Candace Killian, to only allow early voting in the Annual School Election this fall since there are no contested elections and no millage increase on the ballot. Motion passed, 6-0.

Candace Killian made a motion, seconded by Rhonda Moss, to approve the 2016-17 school calendar. Motion passed, 6-0.

Mike McCandlis made a motion, seconded by Julia Chapman, to approve student handbook changes for the 2016-17 school year. Motion passed, 6-0.

Robert Reeves made a motion, seconded by Mike McCandlis, to approve the proposed 2016-17 classified salary schedule. Motion passed, 6-0.

Candace Killian made a motion, seconded by Rhonda Moss, to raise substitute pay to \$60 per day for classified subs, \$60 per day for licensed subs without a teacher's license, \$65 per day for licensed subs with a teacher's license, and \$20 per trip and \$40 per day for bus driver sub pay. Motion passed, 6-0.

Julia Chapman made a motion, seconded by Candace Killian, to accept the resignation of Custodian Wanda McVey for the 2016-17 school year. Motion passed, 6-0.

Rhonda Moss made a motion, seconded by Candace Killian, to approve transfers. Motion passed, 6-0.

Superintendent Fred Walker commended the Arkansas Department of Corrections North Central Unit inmate crew for their help in sprucing up both campuses recently. Walker noted that the inmate crew has been of invaluable help for the district over the years.

High School Principal David Harmon announced that Hayden Ekenes had competed in the 2016 Amateur Trapshooting Association Grand American Tournament in Sparta, Illinois, over the summer.

Middle School Principal Billy McBride announced that the School Livestock Team had won several awards at the Fulton County Fair recently.
