The IZARD County Consolidated School Board met in regular session on July 16, 2018, in the IZARD County High School Board Room.

Roll call showed Robert Reeves absent.

Debbie Moody made a motion, seconded by Julia Chapman, to approve the minutes of the June 18, 2018, regular meeting. Motion passed, 6-0.

Mike McCandlis made a motion, seconded by Danny Blankenship, to approve the financial report. Motion passed, 6-0.

Rhonda Moss made a motion, seconded by Julia Chapman, to accept the resignation of Technology Coordinator Steven Walker. Motion passed, 6-0. Walker has accepted a technology position with state's Team Digital Program.

Debbie Moody made a motion, seconded by Candace Killian, to employ Jed Yarnell as ISS Paraprofessional for the 2018-19 school year. Motion passed, 6-0.

Board member Mike McCandlis left the meeting at this time and returned after the annual bids were awarded.

Danny Blankenship made a motion, seconded by Debbie Moody, to continue to do business with Reeves Propane, Inc., (Board member Robert Reeves is owner) Knockout, Inc. (Board member Mike McCandlis is owner), and the Pacesetting Times (Maintenance worker Randy Sherrell is the husband of owner) because they are located in the school district and offer competitive prices. Motion passed, 5-0.

Candace Killian made a motion, seconded by Danny Blankenship, to approve the annual bids of Knockout, Inc., Kallsnick, Inc., Melbourne Sanitation, and IZARD County Propane. Motion passed, 5-0.

Mike McCandlis made a motion, seconded by Rhonda Moss, to accept the bid from Hill's Auto Sales for two used vehicles with a trade-in of three used vehicles. Motion passed, 6-0.

Debbie Moody made a motion, seconded by Candace Killian, to accept a bus bid for a 71-passenger bus from American Bus Sales. Motion passed, 6-0.

Mike McCandlis made a motion, seconded by Danny Blankenship, to approve increasing substitute pay to \$75 for licensed staff, \$65 for classified staff, and \$42 for bus drivers. Motion passed, 6-0.

Rhonda Moss made a motion, seconded by Julia Chapman, to approve the district's support for the IZARD County Mitigation Plan. Motion passed, 6-0.

Candace Killian made a motion, seconded by Rhonda Moss, to approve the student transfers. Motion passed, 6-0.

Superintendent Fred Walker told the board that the high school gym lobby was being renovated this summer and work should be completed before school starts. Walker also noted that the elementary gym was being painted and several classrooms and offices on both campuses were being painted as well.

Mike McCandlis made a motion, seconded by Debbie Moody, to adjourn at 8:05 p.m. Motion passed, 6-0.
