The IZard County Consolidated School Board met in regular session on June 14, 2017, in the IZard County High School Board Room.

Roll call showed Julia Chapman and Mike McCandlis absent. McCandlis arrived during the meeting.

Robert Reeves made a motion, seconded by Danny Blankenship, to approve the minutes of the May 24, 2017, regular meeting. Motion passed, 5-0.

Candace Killian made a motion, seconded by Rhonda Moss, to approve the financial report. Motion passed, 5-0.

Superintendent Fred Walker told the board that the elementary school, the middle school, and the high school were all fully accredited with no citations this year in the Arkansas Department of Education's Annual Accreditation Report. Walker said that having 100 percent of the district's three schools fully accredited is an excellent achievement for the district and its staff. Walker said that the Arkansas Annual Accreditation Report showed that less than 50 percent of the state's school districts had all of its schools fully accredited without any citations this year.

Walker also discussed the 2015-16 school audit with the board.

Robert Reeves made a motion, seconded by Danny Blankenship, to accept the resignation of Elementary Teacher Donna Stevenson. Walker told the board that Stevenson had worked for the district for 37 years and will be greatly missed. Motion passed, 5-0.

Debbie Moody made a motion, seconded by Rhonda Moss, to move Meredith Cole to the first grade position, employ Angela Middleton as an instructional aide for the elementary library and middle/high school dyslexia students, and reassign John Walker to teach three Social Studies classes in the middle/high school and continue his Elementary Media Specialist position the rest of the day. Middleton will be elementary library aide while Walker is at the middle/high school campus. Motion passed, 5-0.

Debbie Moody made a motion, seconded by Rhonda Moss, to approve a \$1948.38 ADE Teacher retention Bonus for all licensed staff minus the \$400 bonus received at Christmas. Motion passed, 5-0.

Mike McCandlis entered the meeting at this time.

Robert Reeves made a motion, seconded by Debbie Moody, to approve the proposed 2017-18 licensed and classified salary schedules. The schedules reflect a \$400 raise for all licensed staff and a proportional increase for all classified staff as well as an additional amount for all staff with 21 and 22 years of experience or more. Walker commended the district's employees for their hard work and dedication to the district. Motion passed, 6-0.

Mike McCandlis made a motion, seconded by Rhonda Moss, to adjourn at 8:40 p.m. Motion passed, 6-0.
