The IZARD County Consolidated School Board met in regular session on November 20, 2013 in the IZARD County High School Board Room.

Roll call showed Robert Reeves absent.

Superintendent Fred Walker presented the district's case in the scheduled expulsion case. Deana Taylor made a motion, seconded by Kenny Morehead to expel student for the remainder of the school year for two serious violations of the school handbook. Motion passed, 6-0.

Deana Taylor made a motion, seconded by Rhonda Moss, to approve the minutes of the October 14, 2013 regular meeting. Motion passed, 6-0.

Mike McCandlis made a motion, seconded by Rhonda Moss, to approve the financial report. Motion passed, 6-0.

Kenny Morehead made a motion, seconded by Deana Taylor to donate a 1997 used International bus to the Arkansas Department of Corrections with the stipulation that it be for the use of the North Central Unit at Calico Rock only. Motion passed, 6-0.

Superintendent Fred Walker announced that Molly Taylor had won the Moss-Gallegos Scholarship selected by the IZARD County Fair Board. Also, several students participated in the Arkansas State Fair and Livestock Show recently and the school's livestock team won the third place Herdsman Award in the junior beef cattle division at the Arkansas State Fair and Livestock Show. The livestock team won the first place Herdsman Award the past two years..

Walker also noted that the annual Kailey Moss Scholarship Fund Chili Supper had raised \$1,300 for the scholarship fund.

High School Principal David Harmon announced that the girls' golf team had won the district and finished third in the state. Jordan Sherrell Falyn Farmer, and Amanda Hutchins were team members and Sherrell and Hutchins made All-State. Also, the volleyball team finished third in the conference and had an excellent 10-5 season record.
