The Izard County Consolidated School Board met in regular session on June 18, 2018, in the Izard County High School Board Room.

Roll call showed all members present.

Mike McCandlis made a motion, seconded by Danny Blankenship, to elect Candace Killian as President for the 2018-19 school year. Motion passed, 6-0.

Robert Reeves made a motion, seconded by Mike McCandlis, to elect Rhonda Moss as Vice-President for the 2018-19 school year. Motion passed, 6-0.

Mike McCandlis made a motion, seconded by Rhonda Moss, to elect Debbie Moody as Secretary for the 2018-19 school year. Motion passed, 6-0.

Debbie Moody made a motion, seconded by Julia Chapman, to approve the minutes of the May 21, 2018, regular meeting. Motion passed, 6-0.

Mike McCandlis made a motion, seconded by Candace Killian, to approve the financial report. Motion passed, 6-0.

Mike McCandlis made a motion, seconded by Debbie Moody, to employ Jared Johnson as agriculture/elementary physical education teacher, Ashley Johnson as Early Childhood/Dyslexia/Art Teacher, and Teresa Jones as Middle School Teacher for the 2018-19 school year. Motion passed, 6-0.

Debbie Moody made a motion, seconded by Candace Killian, to move Art/Dyslexia Teacher Courtney Sanders to Middle School Teacher and move Middle School Teacher Maggie Campbell to High School English Teacher for the 2018-19 school year. Motion passed, 6-0.

Robert Reeves made a motion, seconded by Julia Chapman, to approve a licensed and classified personnel policy proposal, effective with the 2018-19 school year, to pay employees for unused sick days above 150 days at the end of each fiscal year at the classified substitute rate of pay for a classified employee and at the licensed substitute rate of pay for a licensed employee. Bus drivers are not eligible for this proposal if they are otherwise employed as a licensed or classified employee of the district. Bus drivers who are only employed as a bus driver by the district who are eligible under this proposal will receive substitute bus driver pay for their days above 150. Motion passed, 6-0.

Rhonda Moss made a motion, seconded by Candace Killian, to approve the 2018-19 Licensed and Classified Salary Schedules. Motion passed, 6-0.

Superintendent Fred Walker reviewed the 2017-18 school audit with the board.

Mike McCandlis made a motion, seconded by Robert Reeves to accept bid from Quality Flooring for new flooring in the gym lobby, 2 classrooms, the board room, and administrative offices. Motion passed, 6-0.

High School Principal David Harmon announced that the Cougar Golf Tournament raised over \$5,000 for the athletic department.

Mike McCandlis made a motion, seconded by Robert Reeves, to adjourn at 8:10 p.m. Motion passed, 6-0.
